WRITTEN BIDS

By means of this duly completed form, Kruso Art will execute bids on behalf of those unable to attend the sale. This service is provided free of charge and on a confidential basis. Kruso Art offers this facility for the convenience of clients who are unable to participate in the auction. Kruso Art shall not be held liable for any errors or failures in the execution of bids in the saleroom, by telephone instructions, or by means of the absentee bid form.

To submit a written bid, please use the bid form enclosed with this catalogue and carefully check the lot numbers, descriptions, and bid amounts you provide. Unlimited bidding orders will not be accepted. Each bid form must contain bids for one single auction only. Alternative bids may be accepted if the word "OR" is clearly indicated between the relevant lot numbers. Please always state a maximum limit. In the event of identical bids, priority will be given to the one received first.

TELEPHONE BIDS

Clients with communication are constrained to execute the offer.

If you participate by telephone, if no bids have been submitted for the lots indicated by you or if lower bids have been submitted than that communicated by you over the telephone, your bid will prevail.

If, for any reason, you are unavailable or the communication is interrupted: (i) you undertake to pay the amount you indicated in the form for the lot in question; (ii) you agree to pay the auction base, in both cases, if there are no higher bids.

- Art. I, paragraph 2, letter dd) of Legislative Decree 231/2007, as amended.
- dd) Politically exposed persons: individuals who currently hold or have held significant public offices within the last year, as well as their family members and individuals with publicly known close ties to them, as listed below:
- 1. Individuals who currently or formerly hold significant public offices include those who hold or have held the position of:
- 1.1 President of the Republic, Prime Minister, Minister, Deputy Minister and Undersecretary, Regional President, Regional Councillor, Mayor of a provincial capital or metropolitan city, Mayor of a municipality with a population of at least 15,000, as well as analogous positions in foreign states;
- 1.2 Member of Parliament, Senator, Member of the European Parliament, Regional Councillor, as well as analogous positions in foreign states;
- 1.3 Member of the central governing bodies of political parties;
- I.4 Judge of the Constitutional Court, magistrate of the Court of Cassation or Court of Auditors, Councillor of State, and other members of the Administrative Justice Council for the Sicilian Region, as well as analogous positions in foreign states;
- 1.5 Member of the central governing bodies of central banks and independent authorities;
- 1.6 Ambassador, chargé d'affaires, or equivalent in foreign states, senior officer in the armed forces, or analogous positions in foreign states;
- 1.7 Member of the administrative, management, or supervisory bodies of companies directly or indirectly controlled by the Italian State or a foreign state, or those with a majority or total ownership by Regions, provincial capitals, metropolitan cities, and municipalities with a population exceeding 15,000;
- 1.8 General Director of a Local Health Authority, hospital, university hospital, and other national healthcare entities;
- 1.9 Director, Deputy Director, and members of the management bodies or those with equivalent functions in international organizations.
- 2. Family members of politically exposed persons include parents, spouse or partner in a civil union or de facto cohabitation, children and their spouses, as well as partners in civil unions or de facto cohabitations.
- 3. Individuals with publicly known close ties to politically exposed persons:
- 3.1 Individuals who, according to this decree, jointly hold the beneficial ownership of legal entities, trusts, or similar arrangements with a politically exposed person or maintain close business relationships with them;
- 3.2 Individuals who only formally control an entity that is publicly known to be, de facto, established in the interest and benefit of a politically exposed person.
- Art. 24, paragraph 6 of Legislative Decree 231/2007, as amended:
- 6. Obliged entities, in cases of high money laundering or terrorism financing risk, shall apply enhanced due diligence measures to clients who, originally identified as politically exposed persons, ceased to hold public office more than a year ago.
